Sally, on the strength of the statements in the brochures, booked a holiday for herself and her sister for the weekend. However, upon arrival at the hotel, Sally discovered that there was no facilities for bungee jumping. Has the hotel breached any section of the Trade Descriptions Act 2011.

4. (a) State three examples of the power of health officers in their performance of their duties under Food Act, 1983.

- (b) State two rights of the innkeeper towards their customers under the Inn Keepers Act 1952.
