Three co-workers (Fred, Mary, and Moe) tell Juan to hurry up and do what the boss says; he holds up the job.

Juan: "I know I can do this quickly once I put on my harness and safety helmet." "I know you are in a hurry. An accident will slow things down; better safe than sorry." "I will get to it as soon as you show me where the harnesses and safety helmets are." "My family is expecting me to come home from work today, so I must wear a harness and safety helmet."

The scenario continues:

Juan does not know how to put on the harness properly. When he asks co-workers, they say they are too busy to help him. When Juan asks Karim for help, Karim responds that Juan had best do the job without the harness or he will fire him.
