He has asked for your guidance in determining the next step he should take. Your recommendation includes conducting a market research. First, explain to him the types of research available (provide examples) and outline the **FOUR (4)** steps involved in conducting a research. (15 marks)

**QUESTION 3**

a) Identify the Big Three of cash management. (3 marks)

b) Jonathan owns a business that is achieving great growth. Unfortunately, he is always experiencing cash shortages. Explain why he is running short of cash when his business is achieving good profit. (12 marks)

**QUESTION 4**

*Rohana runs a supermarket in her 'kampung'. Her supermarket is called Rohana Runcit or RR. RR Supermarket sells food and beverages, toiletries, personal hygiene; a concept that is very similar to KK Supermarket. Additionally, RR sells fresh vegetables, fruits and specially made ice-blended drinks. Rohana discovers that the vegetables, fruits and ice-blended drinks are selling very well but products like canned foods, snacks and canned drinks are not selling very well (slow moving products).*

From the statement above, discuss **FOUR (4)** types of pricing strategies that would be suitable for *Rohana Runcit* to adopt to sell her slow moving products and why? Provide examples to illustrate your answers. (20 marks)

**QUESTION 5**

When choosing location for a business, there are common factors that an entrepreneur should consider carefully. Compare and contrast **FIVE (5)** common factors (five factors for each location) which would influence an entrepreneur in site selection for the following:

i) A Spa & Bath (for relaxation) (10 marks)

ii) Branded Handbags (10 marks)
