**Question One**

AB Company is about to embark on a restructuring programme which will mean significant changes to the roles and responsibilities of staff in the Housekeeping Department.

It is anticipated that there will be some resistance to the proposed changes, so the Board of Directors in AB Company has asked Kate, a senior manager in the department, to lead the changes. The Board has chosen Kate because she is generally well liked and respected by her colleagues. She is also held in high regard for her expert knowledge and her interest in, and support she gives to, all those who work for her.

- a. Identify and describe the **FOUR (4)** different sources of power Kate possesses in which could help her to manage the changes in the Housekeeping Department. Provide relevant examples to support your answer.

## Question Two

DD Company, a relatively new company, is in the business of designing and building farm equipment and machinery. Whilst it has been successful in its first few years of operation, sales are now in decline as competition in the industry has intensified and there is greater rivalry between competitor organisations.

A review undertaken by consultants has recommended that, in order to gain sustained competitive advantage, the company needs to establish the basis on which it can compete more effectively against its rivals in the future. Competitive advantage is anything that can give an organisation an edge over its rivals and competitors. An important aspect of competitive advantage is that it needs to be sustained over time, rather than being short-lived. It is important for DD Company to understand on what basis it will seek to achieve competitive advantages since, to be sustainable, it must identify those activities that competitors cannot easily copy and imitate.
