1. In order to produce high-quality baked goods, the baker must have the skill and the understanding of the Four Cardinal Rules of Baking. Explain the **FOUR (4)** Cardinal Rules of Baking. (12 marks)
 2. Below are some of the ingredients for a chocolate cake. The weight of flour is given and the proportions of other ingredients as baker's percentages are shown. You are required to show the calculation process. (5 marks)

<u>Chocolate Cake Recipe</u>	
Cake flour	355 gm
Baking powder	26 gm
Shortening	50 %
Cocoa	7 %
Milk	75 %
Caster sugar	245 gm

- a) Calculate the weights needed for shortening.
- b) If a formula contains 7% cocoa and flour is 500 gm, determine the amount of cocoa needed.
- c) You want to change the recipe by adding 100 gm of pastry flour into the formula. How much of milk do you need?
- d) Calculate baker's percentages for caster sugar.
- e) Calculate baker's percentages for baking powder if the amount of cake flour is 650 gm.

3. Yeast is a leavening agent used widely in bread product. Bakers who prepare straight yeast dough are interested in reliable yeast. Known as bakers' yeast, which is grown commercially. There are many different types of commercial yeast available in the market. They include fresh or compressed yeast, active dry yeast and instant dry yeast.
- a) Compare and contrast the characteristic of the above stated yeasts. (8 marks)
 - b) Describe the correct procedures for working with each of the above stated yeasts. (5 marks)
4. Mousse is defined as any soft or creamy dessert made light and fluffy by the addition of whipped cream, beaten egg whites or both. Some mousses contain both beaten egg whites and whipped cream.
- a) Explain why most chefs prefer to fold in the egg whites first, even though they may lose some volume. (3 marks)
 - b) Michael was preparing a vanilla mouse but the mousse texture was too dense, rough and egg white particles can be seen. What are the possible causes related to the fault in Michaels mousse production? (6 marks)
 - c) If you wish to add gelatin into mousse mixture, what precautions need to be taken when using gelatin? (7 marks)
5. Gluten is a substance made up of proteins present in wheat flour.
- a) You are required to explain how gluten is developed. (8 marks)
 - b) Describe characteristics of good quality of gluten. (2 marks)
 - c) In a standard focaccia recipe, large amounts of oil are added; in brioche, lots of butter is added. In your opinion, does the amount of fat added to flour actually limits or slows the development of gluten? (4 marks)
